

Town Hall - Access to Services - Under Limited Access Procedures

To reduce the spread of COVID-19 we have closed access to Town Hall. Given these circumstances we have established new approaches to provide services. We have initiated a method to drop off applications, permits, payments, and conduct other business, without direct access. We are open for phone calls, emails, and access to a Drop Box which is located at the front of the building. Therefore we ask that you use our webpages, download application forms, use online payments, mail in the information, call us, or use the Drop Box. Please feel free to call or email any of the below contacts. Please make sure when you use the Drop Box, at the front entrance, that your **materials are in a sealed envelope, and well marked with contact information**. Large plans can fit into the Drop Box providing they are folded. Payments should be in a sealed envelope, included with the applicable forms. The Drop Box is accessed multiple times throughout the day. **NO CASH IN THE DROP BOX.**
